FIRST AMENDMENT TO AGREEMENT FOR REFUSE COLLECTION SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR REFUSE COLLECTION SERVICES ("First Amendment") is made and entered into effective this _____ day of ________, 2024 (the "Effective Date"), by and between the CITY OF COMMERCE CITY, a Colorado home rule municipality whose address is 7887 East 60th Avenue, Commerce City, Colorado (the "City"), and ALLIED WASTE TRANSPORTATION INC. d/b/a REPUBLIC SERVICES, INC a Delaware corporation whose principal business address is 18500 North Allied Way, Phoenix, AZ 85054 ("Contractor"). City and Contractor may also be referred to as a "Party" or collectively as the "Parties."

RECITALS

WHEREAS, on December 2, 2019, the Parties entered into an Agreement for Refuse Collection Services (the, "Agreement");

WHEREAS, the Parties desire to amend the pricing for the Services and total compensation, outlined in Exhibit A in the Agreement;

WHEREAS, the Term of the Agreement expires on December 31, 2024, and the Parties desire to the extend the Term of the Agreement for one year to December 31, 2025; and

WHEREAS, except as modified by this First Amendment, the Parties intend that the remaining terms and conditions in the original Agreement shall remain unchanged and in full force and effect.

NOW THEREFORE, for and in consideration of the premises and mutual agreements hereinafter set forth and other good and valuable consideration, the receipt of which the Parties hereby acknowledge, the City and Contractor agree to the following amendments to the Agreement:

ARTICLE I

AMENDMENTS TO THE AGREEMENT

- 1. Exhibit A. The Exhibit A(II) included in the Agreement is amended by the Exhibit A(II)-1 attached to this First Amendment, and incorporated by reference. All references to Exhibit A(II) in the Agreement or anything attached and incorporated therein will be understood to now be referencing Exhibit A(II) as amended by Exhibit A(II)-1.
 - 2. Compensation. Section A of Article II is deleted and the following is inserted in its place:

As compensation for performance of the Services and any other obligations under this Agreement, the City will pay Contractor for work actually performed, in accordance with the rates set for in Exhibit A, as amended by Exhibit A(II)-1. The compensation established by this Agreement includes all of Contractor's costs and expenses to fully perform the Services and other obligations of this Agreement. Under no circumstances shall the Contractor's total compensation for Services performed under this Agreement, as amended, exceed TWENTY ONE MILLION THREE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$ 21,300,000.00). The City will not consider or be obligated to pay or reimburse Contractor any other charges or fees and Contractor

will not be entitled to any additional compensation or reimbursement.

- 3. <u>Term.</u> The Term of the Agreement is extended through December 31, 2025.
- 4. Remainder of Agreement in Full Force and Effect. Except as otherwise provided by this First Amendment, all other terms and conditions of the Agreement shall remain unchanged and in full force and effect and shall apply to this First Amendment.
- 5. <u>Authority</u>. The Parties represent and warrant that they have taken all actions necessary to legally authorize the undersigned signatories to execute this First Amendment on behalf of the Parties and to bind the Parties to its terms.
- 6. <u>Counterparts; Execution</u>. This Agreement may be executed in any number of counterparts, each deemed to be an original, and, taken together will constitute one and the same instrument. Signature pages may be executed via "wet" signature or electronic mark and the executed signature pages may be delivered using pdf or similar file type transmitted via electronic mail, cloud-based server, e-signature technology or other similar electronic means.
- 7. <u>Headings</u>. Paragraph headings used in this First Amendment are for convenience of reference and shall in no way control or affect the meaning or interpretation of any provision of this Second Amendment.
