COMMENCING AT THE SOUTHWEST CORNER OF SAID LOT 2, SAID POINT BEING ON THE EAST RIGHT OF WAY LINE OF ROSEMARY STREET; THENCE S89°58'03"E ALONG THE SOUTH LINE OF SAID LOT 2 A DISTANCE OF 10.00 FEET TO A POINT ON THE EAST LINE OF A 10 FOOT TRANSPORTATION EASEMENT, SAID POINT BEING THE **TRUE POINT OF BEGINNING**; THENCE N00°40'15"E ALONG SAID EAST LINE AND ALONG A LINE 10 FEET EAST OF AND PARALLEL WITH THE EAST RIGHT OF WAY LINE OF ROSEMARY STREET A DISTANCE OF 45.00 FEET TO A POINT ON THE SOUTH LINE OF LOT 1, MSC SUBDIVISION; THENCE S89°58'03"E ALONG SAID SOUTH LINE A DISTANCE OF 156.87 FEET; THENCE S00°01'57"W A DISTANCE OF 45.00 FEET TO A POINT ON THE SOUTH LINE OF SAID LOT 2; THENCE N89°58'03"W ALONG SAID SOUTH LINE A DISTANCE OF 157.37 FEET TO THE **TRUE POINT OF BEGINNING**;

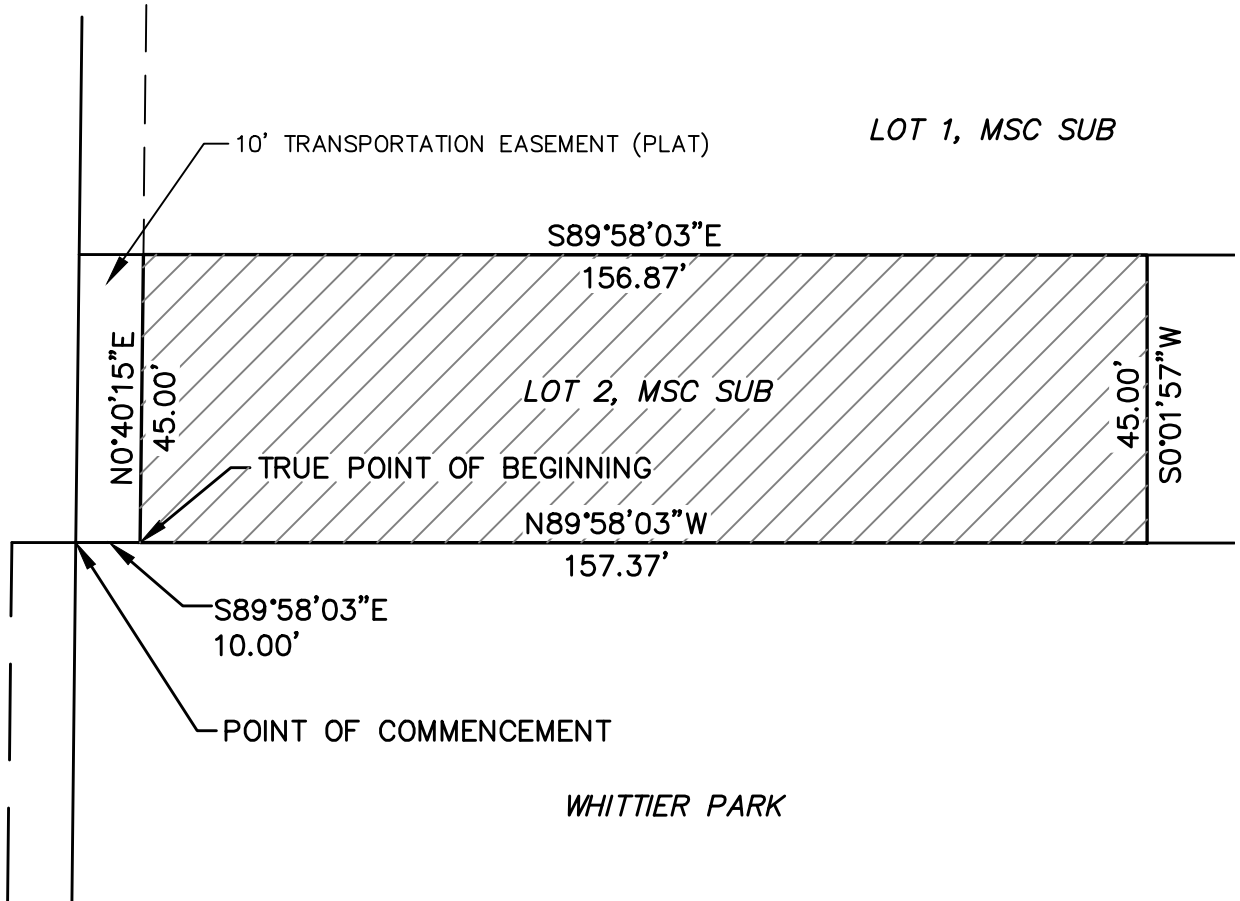
