## REQUEST

Approve a budget ordinance to amend the 2025 budget of the City of Commerce City to recognize Off-System Bridge Program grant funds in the amount of \$720,000 for rehabilitation of the bridge at Tower Road and Third Creek.

## BACKGROUND

The Off-System Bridge Program's primary objective is to inventory, inspect, evaluate, replace and rehabilitate major structures on public roads in Colorado counties and municipalities. The City of Commerce City ("City") applied for funding in 2023 for the rehabilitation of the bridge at Tower Road and Third Creek to maintain safety and capacity on Tower Road.

In December 2023, the City was awarded federal funding from the Colorado Department of Transportation ("CDOT") through the Off-System Bridge Grant Program to rehabilitate the bridge at Tower Road and Third Creek. Public Works will begin the procurement process the summer 2025, and rehabilitation work will begin in 2026. The City is providing \$180,000 in match funding from the Bridge Maintenance Program Fund.
