Second Creek Trail Closure

A section of the Second Creek Trail is closed for tunneling work between E. 104th Avenue and E. 106th Way through May 31. Installation work on the Second Creek Pipeline (being constructed by Metro Water Recovery) is expected to be complete by early May, with restoration of the area completed by end of May. Staff hopes the restoration matures enough in June and July to be ready for the PRG Tour de Donut event in August. Detour and closure signage is posted to include estimated closure dates, and notifications about the closure have gone out to the public.

Executive Summary

This update is intended to provide a weekly update of environmental policy and planning work including, but not limited to:

- Environmental Policy Advisory Committee (EPAC), Lotus Contract and Community Outreach
- Municipal Sustainability
- Updates on information regarding the Suncor Refinery and its operations
- Legislative Updates & Regional Environmental Leadership
- Colorado Oil and Gas Conservation Commission (COGCC) Regulations & Applications

Environmental Policy Advisory Committee (EPAC) and Community Outreach

Dr Russo and a potential EPAC member met to discuss a partnership between Northglenn and Commerce City for outreach and grant proposals. Northglenn Council approved their Sustainability Action Plan a few weeks ago so a review of respective Plans are underway. Northglenn will be hosting a Forum that they invited Commerce City to participate in to address:

- Increased awareness of global impacts caused by Climate Change around the world.
- Impacts on food systems, energy markets, etc.
- How to focus on our region's greater risks based on Climate Change.
- Acknowledge different risks faced by those in different parts of the world.
- Increased awareness of what the City is doing to address Climate Change (City Actions).
- Build connections for participants working in the area and identify possible multi-jurisdictional collaborations.

Lotus Engineering & Sustainability Contract Progress

Lotus met with staff to discuss final revisions to the Low Impact Development Guidance document and draft Ordinance. Both CD and PW staff recommend a mandatory approach to storm water management given the water contamination and problems with ice on streets and sidewalks throughout the winter months. Staff have designed checklist for developers and PW review staff to streamline the process and align with the new electronic Review software Central Square.

Municipal Sustainability

The Sustainability Team is working together to align sustainability related events and educational opportunities given both the internal and external committees ranked building internal capacity as an essential component of implementing triple bottom line planning into the organization and community.

Suncor Refinery

Following the Air Quality Investigation and Research for Equity (AIRE) Forums which centered on dispersion; air quality community and regulatory data analysis from 2023, two graduate students have initiated conversions about legal and public health research related to Suncor operations. Major issues are the differences between regulatory averaged limits and the continued spikes that could impact acute and chronic health of residents and employees working in Commerce City.

Legislative Updates & Regional and State Environmental Protection Leadership

Dr. Russo attended the third NREL study session on renewable energy procurement options including the availability; advantages and disadvantages or Renewable Energy Credits (RECs) vs on-site renewable energy generation such as:

- Differences in REC prices create an opportunity to conduct arbitrage to meet goals and reduce costs
- Buyers with bundled RECs in markets with high REC prices may sell their RECs and then purchase lower
 cost RECs in another market (termed "arbitrage" or "swap"). This swap enables the buyer to lower their
 costs and still claim the clean attributes.
- Swaps may happen at a 1:1 ratio or at other ratios, depending on the preference and price differentials.

Part of the evaluations included enhanced finacing mechanisms such as

- The IRA extended the Investment Tax Credit (ITC) and Production Tax Credit (PTC) for the next ten years,
 which provide significant savings
- Federal grant programs like the Energy Efficiency and Conservation Block Grant
 Program (EECBG) and Climate Pollution Reduction Grants can provide resources
- The IRA's new direct pay mechanism allows for local governments to directly claim various energy tax credits for the first time.



Oil & Gas Updates

Staff and several other local governments have expressed concern with the Hansen bill and proposed mission change to COGCC including but not limited to:

- The regulation and permitting of hydrogen storage in subsurface formations, the transportation of hydrogen through pipeline(s), and any other hydrogen operations related to or interconnected with the Commission's directive and regulatory responsibilities in the State of Colorado, and
- The existing administrative structure for pipeline siting and safety regulation for operations related to or interconnected with the Commission's directive and regulatory responsibilities.

Staff continues to work with Civitas on necessary documentation and additional state requirements.

No additional information has been submitted by either applicant. Submittals with no status changes are listed in Appendix A.
