



#### **Suncor Update**

#### Air Monitoring CCND

- Q3 2022 (July 1 Sept. 30, 2022) Acute Health Risk Assessment:
  - The data indicates that all concentrations of the compounds measured are likely to be without adverse acute health effects, even for sensitive individuals according to federal health assessment guidelines. This is true for compounds measured individually and cumulatively as a group. The latest reports are consistent with all previous quarterly reports.
- Q3 2021 Q3 2022 Chronic Risk Assessment:
  - The data collected over the last 15 months did not indicate a potential for chronic non-cancer adverse health effects from exposure to the measured chemicals, both individually and combined, in either the CCND neighborhoods or the reference sites.

#### Air Exceedances

**Event Date**: 11/11/2022

**Event Title**: Plant 3 Main Plant Flare Exceedance

Impacted Media (air, water, or soil): Air Operating Unit: Plant 3 Main Plant Flare

Event Summary: During normal operation, Plant 3 began rapidly losing instrument air pressure. Soon after the air pressure had started to fall, operations personnel safely shutdown the unit by shutting down the heaters. When Plant 3 lost instrument air, the valve that adds supplemental natural gas to the flare (and thereby controls the flare's combustion zone net heating value (NHV)), was not able to open and caused the flare net heating value to decrease. Operations personnel opened the bypass around the valve that would not open and began to rebuild pressure to put the unit into circulation to restart the unit once it was stable. This event began on 11/11/2022 at 5:15 a.m. and ended on 11/11/2022 at 5:30 a.m. when instrument air was returned to operational status and supplemental fuel was added into the flare. The specific permit terms or conditions exceeded for this event include: Permit Term or Condition Reported Value Combustion zone net heating value (NHV) shall not be less than 270 Btu/scf (15-minute block average) 146 Btu/scf (15-minute block average)

The Commerce City North Denver Air Monitoring network of sensors within a three-mile radius of the refinery did not detect any levels above the acute health reference guidelines during this event. Suncor is investigating this event to determine root cause and appropriate corrective actions
