Current Homelessness Efforts in Commerce City

- Severe Weather Activation Plan (SWAP)
 - 5 activations
 - ▶ 34 vouchers administered
 - ▶ 23 nights of motel stays
- Community Development Block Grant (CDBG)
 - Awarded 10k for outreach supplies & service-related resources
- ▶ Point In Time (PIT)
 - Participating in regional surveying of unsheltered homelessness in Commerce City
 - Jan 25th
 - ACCESS Housing, Park Rangers, & YHC volunteers

- Mobile Sanitation Services
 - ► Laundry & showers
 - ACCESS hosting ShowersForAll monthly
- Volunteer Outreach Program
 - ► YHC undertaking CU Med students
 - ▶ 21 medical students, 4 medical prescribers & 2 registered nurses
 - Scheduling platform 2x/week
- Safe Parking Lot
 - Nativity Lutheran Church & CSPI to open a 7-car only lot

American Rescue Plan Update

State and Local Fiscal Recovery Funds Review

- ► The City is eligible to receive approximately \$10.5 million in SLFRF as part of the American Rescue Plan Act (ARPA).
 - Issued in Two Equal Tranches of approximately \$5.25 million
 - ► Tranche 1 Received in July 2021; transferred to City funds as Revenue Replacement.
 - ► To receive the second tranche in mid-2022, the City must spend or attribute the entirety of the First Tranche through any of the ARP allowable use categories.
- ► The Department of the Treasury issued its Final Rule on allowable uses of SLFRF on January 6th, 2022.
 - ► Staff has worked with the Treasury and identified a number of options that would likely qualify as an Allowable Uses for "Promoting Long-Term Housing Security" under the final rule.

Previous Direction from Council

- ► Council direction to staff in July 2021 was to 'act boldly' with the funds to address and end homelessness in Commerce City.
 - ► Particular emphasis on providing individuals job training, addiction counseling, and other 'wrap-around' services.
 - ▶ Decision to address homelessness with a large portion of the SLFRF was made after Council worked closely with staff on identifying a number of priorities.
 - ► Staff has since worked on identifying the projects and/or programs for which we could utilize the funds

Homelessness Project and Program through SLFRF

Addressing homelessness in Commerce City will take two components:

SLFRF Project

- Physical space purchased, constructed, or renovated by the City
- Provides temporary or permanent housing and emergency shelter
 - Numerous options currently being explored: "pallet" shelters, transitional housing, and permanent supportive housing.
- Central location to provide services with private offices and common spaces
- The SLFRF Funding alone will likely not be enough to fund a brick-and-mortar facility.
 - Partnerships with Private Sector, Non-Profit, and other Municipalities will be necessary to complete the capital stack.

SLFRF Program

- Network of 'wrap-around' services that can utilize the project space
- Key services identified by staff: job training, case management, washrooms, medical and addiction services, and animal-friendly spaces
- Less up-front costs, requires on-going staffing and maintenance costs
- The SLFRF Funding alone will not be enough for funding the programming.
 - Partnerships with non-profits and other government entities will be necessary to support this effort.

Collaborations on Homelessness

- ► Homelessness cannot be solved or addressed by any one municipality or County. Collaboration is necessary to address the root causes of homelessness.
- ► Staff has worked closely with the *Adams County Housing and Homelessness Municipal Working Group* to coordinate homelessness response efforts across the County.
 - ► Working Group has created an MOU which affirms each municipality's and the County's commitment to collaboration on homelessness.
 - ▶ MOU to be presented to Council for review in Q1 2022.
 - ▶ No financial commitment from City will be made as part of MOU.
 - Working Group allows for information and resource sharing, more efficient by decreasing duplication of services.
 - ► County Commissioners planning 'Road Show' for Adams County Municipal Councilmembers as part of homelessness effort for February 2022.

Next Steps - ARPA

- Completion of mapping project to identify best locations for Navigation Center and other temporary housing and shelter options.
 - ▶ Once map is complete, staff will conduct cost analyses on potential locations.
- ▶ First tranche must be completely attributed by Summer 2022.
 - ▶ Revenue replacement
 - ▶ Capital improvement/construction
- Once first tranche is attributed, staff will apply for Second Tranche.

Next Steps - Pallet Shelters

- Staff approached by Adams County to identify potential locations in Commerce City for a small set (4-8) of 'Pallet Shelters'.
 - Current discussions involve Adams County or their non-profit partners staffing and maintaining location.
 - City would be responsible for providing location only.
- Coordinating with Community Development, GIS, and Community Navigator - Homeless Outreach on identifying locations.
- Once locations are identified and evaluated, staff will return to Council with recommendations.

Next Steps - MOU on Homelessness

Purpose

Strengthen regional coordination and improve outcomes for people experiencing homelessness or at a risk of homelessness through a shared vision.

Goals

- Shared data
- Identify areas of opportunity to provide a system of services and housing
- Development of a single navigation and entry system
- ▶ Identify possible funding sources
- Identify possible development partners

Outcomes

- More collaboration between the local governments in making homelessness rare, brief and one time
- ► Improved service provision and infrastructure
- Increased housing opportunities
