AN ORDINANCE AMENDING THE 2022 BUDGET OF THE CITY OF COMMERCE CITY, COLORADO BY THE RECOGNITION OF THE DRCOG SAFER MAIN STREET PROGRAM GRANT IN THE AMOUNT OF \$2,720,000 AND THE EXPENDITURE THEREOF

WHEREAS, the City of Commerce City ("City"), intends to design and construct road widening and other improvements along Colorado Boulevard for the section of road between 68th Avenue and 70th Avenue; and

WHEREAS, DRCOG Safer Main Street Program grant will reimburse the City 80% of the total cost of the Design Services, and the City has agreed to contribute 20% of the total cost. The total estimated cost or the project is \$3.4 million. The \$3.4 million is broken out as \$2.72 million from DRCOG and \$680K from the City; and

WHEREAS, the contract proposal from Michael Baker International (MBI) for completion of the Design Services as submitted to the Parties is \$485,871.32 with anticipated amendment to contract for acquisition of right-of-way and easement;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

SECTION 1. Findings. The recitals to this ordinance are incorporated as findings of the City Council. This ordinance is found to be necessary for the preservation of the public health, safety, and welfare and in the public interest.

SECTION 2. An amendment is made to the 2022 budget of the City of Commerce City, Colorado by transferring \$2,720,000 from DRCOG Safer Main Street Program.

SECTION 3. Repealer. All other ordinances or portions thereof inconsistent or conflicting with this ordinance or any portion hereof are hereby repealed to the extent of such inconsistency.

SECTION 4. Effective Date. This ordinance shall be effective immediately upon passage on second and final reading.
