## Strategic Plan Next Phase - Housing Study

#### Housing Study and/or Market Analysis

- Provide an assessment of current housing and housing needs and also provide information to help develop a city-wide plan for housing development in Commerce City benefiting the City, the Housing Authority and the City's residents
- May help support the Assessment of Community
   Needs required for becoming a CDBG Entitlement
   Community
- Identify indicators of housing supply and demand



## Strategic Plan Next Phase – Housing Study (Cont.)

- Identify and quantify greatest community housing needs both now and in the future
- Serve as a basis to create a housing-related timeline, both short term and long range
- Review existing and assist in development of new policies, programs and strategies
- Provide a mechanism to determine the organizational impact of housing development, e.g. partnership opportunities, funding requirements, and staffing

#### **Current Staffing Issues**

- Office Closure Challenges:
  - Off-site inspections, meetings and time off
- Housing Choice Voucher (Section 8)
   Administration
  - New expanded reporting requirements and annual waitlist recertification (currently at approx.1,750 applicants, which is nearly 1/3 of the total state-wide waitlist)
  - 110 vouchers, highest number of vouchers in 10+ years
  - Homeownership program
- CCHA Development Projects
  - Conter and other New Partnerships



#### Additional Staff Needed

- Office coverage when Housing Coordinator is out of the office
- Clerical duties filing, answering phones and returning calls
- File maintenance and administration
  - Requires knowledge of HUD Housing Choice Voucher (Section 8) requirements



### Request for Consideration in 2016

- Additional funding to do a Housing Study as a partnership effort between both the City of Commerce City and the Housing Authority
  - Costs depend on scope of study and amount of public input.
- Additional funding for a full-time new staff member
