Criteria Background

- Staff has been refining a 5 year Capital Improvement Program for the last 6+ months since the City Council retreat Jan, 2015
- June 8 City Council initial review of 5 year
 CIP
 - Directed staff to develop criteria for projects and review with CIP-CAC
- July 15 Staff reviewed draft criteria with CIP-CAC then revised based on input

Background

- Initially, staff drafted 6-9 review criteria and assigned initial weights to each category
- CIP-CAC provided input and staff finalized a set of 12 criteria
- When scored, each project will receive a raw score in each category and have the weight applied to reflect a total score
- The initial system results in a total possible score of 265 points

CIP Project Criteria / Application

- Staff applied the revised criteria to all 54 projects currently requested for the 5 year CIPP
- Staff is seeking final approval from City Council on the criteria before updating the 5 year CIPP
- Decisions about which projects to fund rest with City Council and the criteria may be used as a system for initial prioritization
- Final projects for the CIPP will be dependent upon funding sources



Definitions and Funding Sources

August 10, 2015

Definition of Capital Expenditure

A capital expenditure is an outlay of significant value that results in the acquisition of or addition to a capital asset that is property held or used for more than one year and typically more than five years.



Definition of Capital Project

A capital improvement project will add value or extend the life of a capital asset. Capital improvement projects, which may include capital construction and capital maintenance projects, for the purposes of this program, are defined as "non-recurring major projects."



Capital Projects

In general, these projects include building improvements and any public infrastructure improvements costing \$50,000 or more. This does not include vehicles and equipment that are acquired and funded through the Fleet Management Internal Service Fund or the routine acquisition of computers, related equipment, or software applications, which are funded through the Information Technology Internal Service Fund. Facility capital projects funded through the Facility Services Internal Services Fund and the Information Technology Internal Service Fund costing \$50,000 or more shall be treated as Capital Expenditures in a "Special Fund" under Section 12.10 "Lapse of Appropriation" provisions of the City Charter, without having to be budgeted within the Capital Improvement and Preservation Plan Fund. Capital projects and fixed assets which generally fall under \$50,000 but more than \$5,000 continue to be budgeted under the capital outlay part of each department's budget request. Commerce

Capital Projects

Needs assessments costing \$50,000 or more that are done in anticipation of or in preparation for a capital improvement project and the preparation or updating of planning documents such as the Comprehensive Plan, Parks and Recreation Strategic Plan, and the Transportation Plan costing \$50,000 or more may also be included in the Capital Expenditures Fund.

Funding Sources

- There are a variety of funding sources
- Most of the funding sources are restricted use
- The restricted use funding sources complicate the project funding and scheduling
- Staff will provide multi-year sources and uses spreadsheets at the retreat to assist Council



Transportation Tax

- Revenue shared by Adams County
- Source is 0.5% Adams County sales tax
- It is to be spent on street projects
- Adams County requested it be used on major projects



Solid Waste

- Classed as an enterprise fund for City
- Revenue is generated by a tipping fee on the BFI Landfill
- Must be spent mitigating the impacts of the landfill operation
- Primary use has been on streets impacted by trucks hauling trash to landfill

Adams County Open Space

- Adams County has a 0.2% sales tax dedicated for open space
- Adams County shares 30% of what is collected in the City with the City
- The money is to be used for construction, acquisition, and maintenance of capital projects relating to open space and/or recreation.

Lottery

- Technically this is the Conservation Trust Fund
- Revenue is generated by lottery ticket sales
- The state shares revenue with the City
- The money is to be used for the development, improvement, and maintenance of parks, recreation, and open-space programs.



General Fund

- The City's General Fund receives a wide variety of revenues
- The purpose is to fund operations of the City
- Limited amounts are available for transfer to fund capital projects
- The limitation is that enough must be kept in the fund balance of the General Fund to ensure uninterrupted operations.

Certificates of Participation (COPs)

- The City can enter into lease-purchase deals on existing City owned facilities to fund additional asset construction
- COPs were issued to fund construction of the Civic Center
- The limit is both the value of City facilities and the amount of annual lease payments that the City can afford.

CIPP Fund Balance

- Occasionally capital projects do not require all of the money appropriated for them
- Money left over from "closed projects" then goes to fund balance
- This money can be recycled into new projects.



Agreements & Grants

- From time to time the City has reimbursement agreements with developers or other agencies
- Also grants are accessed whenever possible to stretch the City's dollars or to provide an enhanced service to the businesses and residents
- These funds are budgeted when available.



NIGID

- The Northern Infrastructure General Improvement District has a 27 mill property tax levy
- This money may only be used for water, sewer, and street improvements
- Most recently this has been used to fund 104th Avenue improvements.



Parks Impact Fee

- This is revenue generated by a fee on new construction
- Annual revenue increases or decreases based on the amount of new construction each year
- The purpose is to fund construction of public parks, trails, and recreation facilities



Road Impact Fee

- This is revenue generated by a fee on new construction in the northern range (East of Union Pacific & N. of 80th Ave. and West of Union Pacific & N. of 88th Ave.)
- Annual revenue increases or decreases based on the amount of new construction each year
- The purpose is to fund construction of road improvements in the district (3) where fees were collected.

Drainage Basin Fees

- This is revenue generated by a fee on new construction in each identified basin
- Currently there are 4 identified basins with fees based on the estimated cost of constructing regional drainage improvements
- This does not fund ongoing operation and maintenance of those improvements
- The basins don't cover the historic city.

Retained Earnings

- Internal Service Funds such as Facility Services and Information Technology receive an allocation from all other City departments
- In some years there is more revenue from allocations than the expenditures and that unspent revenue is classed as retained earnings
- Retained earnings may be spent for like purposes or transferred back to the General Fund

Capital Project (Uses)

- New projects have been identified as priorities by staff for consideration in 2016-2020 CIP
- Staff has identified possible funding for many of the projects
 - Funding includes pass through dollars
 - Some projects could be funded from 2K bonds
 - But projects eligible to be funded from 2K exceed what is available from 2K bond authorization

Requested Projects Not Funded

- General Fund has more requests than funds
- Projects unable to be funded total over \$101 million
- Some new projects may be candidates for 2K bonds as a follow-up to the original 5
- Total of following 6 proposed projects alone is approximately \$70 million
 - Northern Loop Trail "Phase 2" = \$3,469,000
 - 104^{th} Avenue Phase 3C = \$6,950,000
 - 88th Avenue Widening = \$25,920,000
 - 96th Avenue Widening, East of Hwy 2 = \$20,500,000
 - 96th Avenue Widening, I-76 to Heinz Way = \$7,450,000
 - Rosemary Street Widening = \$6,040,000



Budget Retreat Exercise

- Staff proposes to bring a spreadsheet matrix to the budget retreat to assist in the Council's deliberation of which projects to fund per year
- The matrix will show which funding sources and the available amounts that may be used for each project
- The criteria ranking is meant to be a tool for Council's deliberation
