# Progress to Date

Commerce

- The City hired Mosaic Community Planning to assist in the development of the City's first HUD CDBG Consolidated Plan.
- Over the spring, Mosaic engaged the community and service providers to gather input on community needs.
- On June 13th, City Council had a study session where Council was updated on the findings from those efforts.
- Since July 1, the draft plan is available for comment in accordance with HUD requirements.

### 1- Year and 5-Year Action Plan

### **Action Plan**

- Every year, an annual Action Plan is developed to describe how Commerce City will use that year's annual allocation of HUD formula funds to meet housing and community development needs identified in the Consolidated Plan. The Action Plan must follow HUD's template and requirements and must be based on the community findings and input.
- City Council will have the opportunity to review the Action Plan each year.

### 1 Year- Annual Action Plan

- 1<sup>st</sup> Year Action Plan Items for new entitlement cities based on feedback and requirements from HUD.
  - Limit number of first year projects (since program is not up and running and no staff has been allocated yet)
  - Focus on projects already "ready to go" with easy administration

 Therefore not all priority areas will be covered each year, especially first year.
