# Needs Assessment

- Street, Road, and Sidewalk Improvements
- Redevelopment/Revitalization of Blighted Areas
- Cost Burden is most common Housing Problem



# Market Analysis


- Scarcity: shortfall of over 1,400 units (9.0%)
- Rapidly increasing rents and housing costs
- 31% of renters spend >\$1,000 per month on rent
- Vacancies in subsidized units are rare
- Waiting lists for vouchers are closed



# Citizen Participation Plan
