#### **Discussion:**

Detailed case information can be found in the staff report on file at the Commerce City Community Development Department.

Planning Manager Timms reviewed the staff report and presentation. The applicant is Werthwhile Inn, Inc./Beverly VanDeWeghe. The applicant is requesting to replace and update an individual business sign to identify this business within the Derby District. The proposed sign that will face west is approximately 45.70 square-feet. The application is to replace an existing wall sign. The requested sign is larger than the existing sign from the building and clearly identifies the use of the facility. In addition, the signage is illuminated and meets the design elements (red and neon) that are harmonious with the Derby color pallet. The existing beer sign will remain.

The subject property is located on a corner lot within the Derby Downtown District. The applicant is the owner of the subject building. The subject building is adjacent to both the Magnolia Street and Highway 2 rights-of-way.

The owners of the property, Joe and Beverly VanDeWeghe, were present to answer questions.

Board Member Hall feels that the sign replacement and anything that will enhance and brighten up Derby while adding to the richness of the entrance to what will hopefully be the Derby Historical Shopping Area is a good thing for the area. The sign may also help people see the property better during the Highway 2 widening project. She advised that the applicants were former members of the Derby Business Association and are strong supporters of the area.

Board Member Teter likes the new sign design and is glad to hear that the business is established in the area and has been at that location in the Derby Downtown District since 1991.
