**SECTION 2.** The City Council of the City of Commerce City, Colorado further finds and declares that it has caused to be published in the Commerce City Sentinel Express, a legal newspaper of general circulation in the City of Commerce City, Notice of Public Hearing held on September 19, 2016 regarding rezoning of land hereinafter described, and that said Notice was published on September 6, 2016 and that said Hearing was conducted all in compliance with law.

**SECTION 3.** That the property described in Exhibit "A" attached hereto and made a part hereof, now zoned Adams County A-3 be rezoned Commerce City Public as defined in the Commerce City Land Development Code.
