ISSUE: Persons being at least 21 years of age and residing or being a business owner or manager within the defined area were contacted to determine if they were in favor or opposed to the issuance of a Retail Marijuana Cultivation Facility License and Retail Marijuana Products Manufacturer License at the above location. Those in favor of Maclone Operations, LLC being granted the licenses indicated by checking the "In Favor" column of the signature sheet, those opposed checked the "Opposed" column and those who were neutral to the issue checked the "Neutral" column. The results were as follows:

PETITION METHODOLOGY

- **Survey Dates and Times:**

Business:	Thursday	September 29, 2016	11:30 am - 4:30 pm
Business and Residents:	Monday	October 3, 2016	2:30 pm - 5:30 pm


- **Survey Coverage:** The defined survey area consisted of industrial businesses and only two residential locations. The circulator performed a complete coverage of all businesses and residents within the defined area on September 29th, 2016. A second attempt was conducted with any location where the owner, manager or resident was unavailable (October 3, 2016). Prior to the second survey attempt, the circulator phoned several businesses to advise them of the survey issue and to make arrangements to meet with owners or managers. (please see attached map)
- **Information Presented to Respondents of the Survey:** The circulator presented information describing the license issue and the company operations. This information included a verbal introduction that Maclone Operations would be cultivating and manufacturing marijuana products at the proposed facility location and an informational flier (produced by the applicant) describing the facility, operations and contact information was either shown or left with the businesses. (please see the attached information flier)
- **Error on the Survey Face Sheet:** The face sheet of the survey indicated that the application was for a Retail Marijuana Cultivation Facility License and after the survey was complete, Liquor Licensing Professionals was notified that the face sheet should have included an additional application for a Retail Marijuana Products Manufacturer License. The circulator of the original survey went back to the defined area on October 14, 2016 and notified all business respondents who signed in favor, that the original information given to them was exactly the same, but that the application was for two licenses.
- **Circulator of the Survey:** There was one circulator for this survey. Prior to the start of the survey, the circulator was briefed on the type of marijuana license application, the areas to be surveyed and reminded to be remain unbiased in her approach to residents and business people. The circulator had with her a face sheet with the applicant business name, location and hearing information, instructions and the petition/survey issue along with signature sheets and a map of the proposed location. The circulator presented an informational flier that was prepared by the applicant, describing the facility and the cultivation and manufacturing plans. The circulator used tally sheets to record all contacts, attempts and reasons for opposition signatures and refusals. At the conclusion of the survey, the circulator signed notarized affidavits of circulation. The original survey packets were pre-filed with the City Clerk's Office.

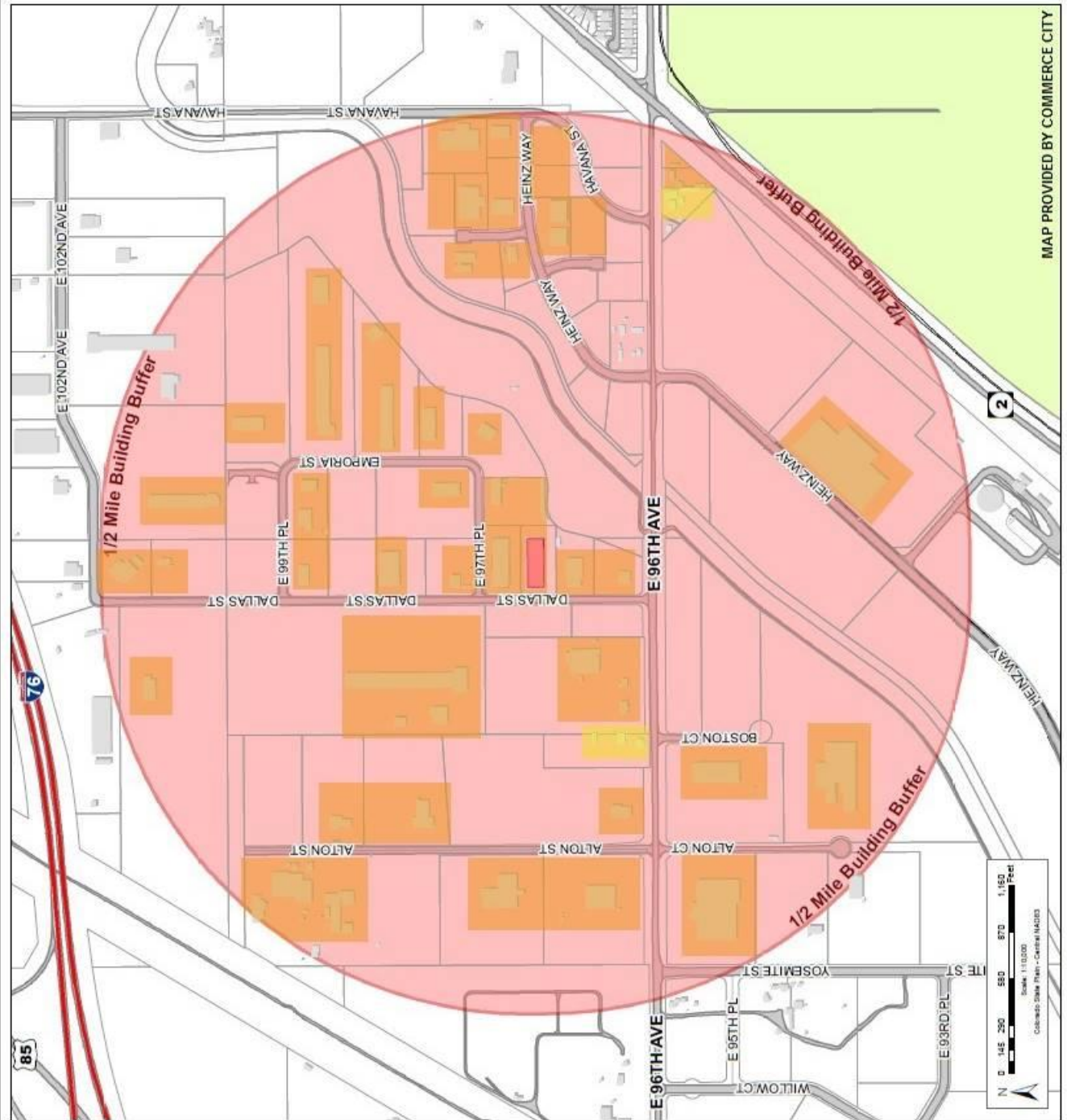

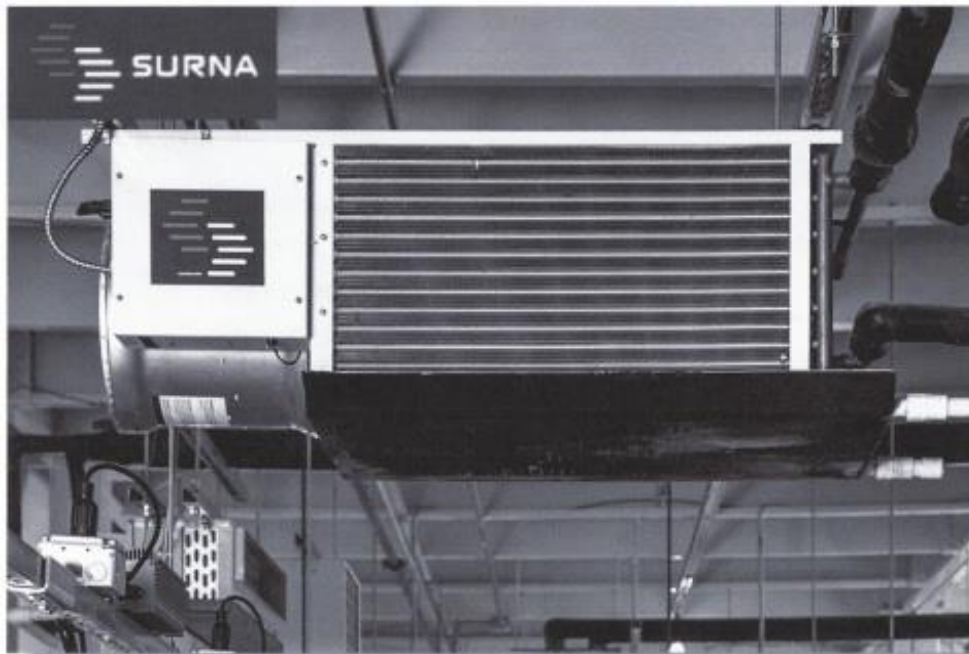
