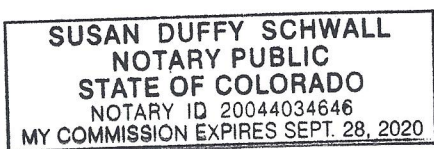

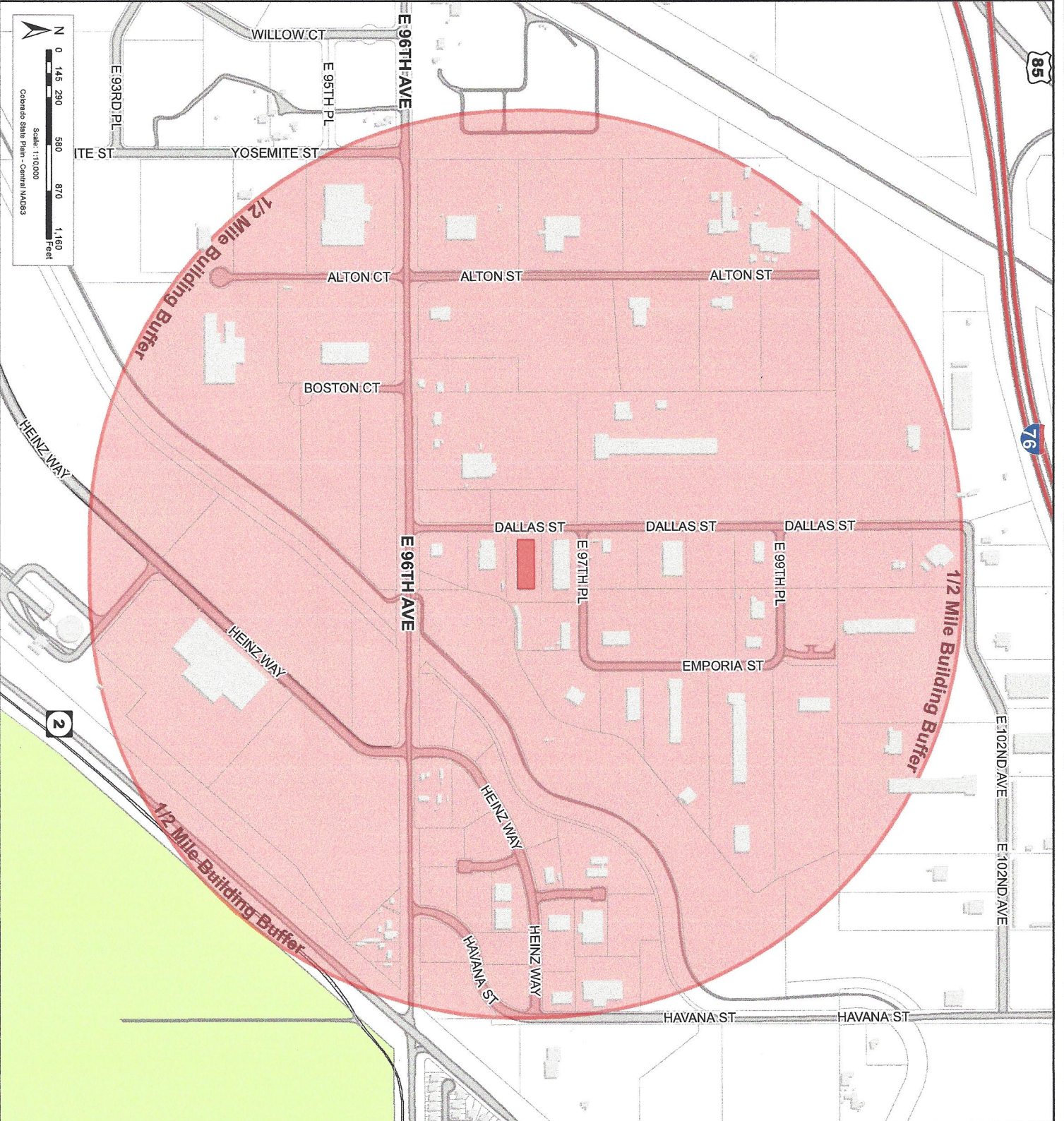

Overview Map



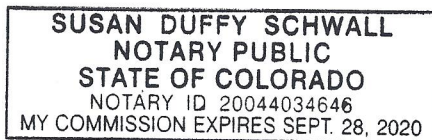
