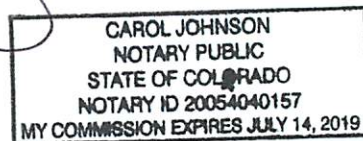
I, ARRON ROENSTAD, being over the age of twenty-one years and being first duly sworn upon oath, depose and state:
