1. Welcome

2. Committee Photo

Moved to next meeting since two members were unable to attend

3. Tower Road Update

- a. Gramma Gulch/Second Creek Box culvert in progress to carry drainage
- i. Located in segment 1, about 12 feet wide and 10 feet tall
- ii. Challenges with Comcast and United Power getting their lines moved
- b. Will install curb and gutter on closed part of Tower Road
- c. Three segments for Tower Road
- i. Added delineators and temporary lighting for safety
- Installing water main crossings in segment 1
- iii. Segment 2 is the primary work right now. Can't drive down segment 2 right now, must use Buckley road detour. Detour will officially end in April, but may keep detour route open after April as an option; landfill would prefer that because their trucks are affected.
- iv. Started streetlight conduit in segment 3; probably won't have detours but will have concrete barriers one line heading south and one heading north
- v. Will work from north to south for lighting; not sure of installation date
- vi. Project is about forty percent complete; on schedule and on budget, to be complete by end of 2017
- d. Committee Question: Is more of the budget going to go to the bigger picture?
- i. Potentially, but still need approval and to calculate other unknown costs

4. Highway 2 Update

- a. Highway 2 is longer than Tower Road, about five and half to six miles
- b. Start at 72nd Avenue, working in first segment; put up silt fence, grading work
- c. Night detours from Quebec to 88th working well; not many options other than night closures for this work
- d. Decorative street lights are starting to come down from United Power
- e. In the process of land acquisition for body shop
- f. Derby park concept helps make easier turns off of Monaco
- i. Will add plants and bigger sidewalks
- ii. Not exactly a park but a great place to sit down and relax
- g. About 12 percent complete; on schedule and on budget for early 2018 completion
- h. Will try to add public art
- i. Committee Input: Take an inventory of signs needed for the little turn area at 72nd and crosswalk at end of the church
- j. Committee Question: What was the point of putting in medians?
- i. To give pedestrians a safe place to stop in between lanes

5. New Recreation Center & Infrastructure Project Update

- a. Located at northern portion of Highway 2
- b. Traffic has been shifted to west side
- i. Pretty narrow for drivers
- ii. March is when they plan to shift traffic back to east
- c. Undergrounding utilities and installing irrigation lines
- d. Committee Question: Why are the lights out and the paint lines almost gone past 104th?
- i. Have to take down existing lights and put in concrete barriers to continue construction. Will look into what they did for Tower and try to add temp lighting
- e. Building status:
- i. Much foundation work and grading is occurring
- ii. Pool pit is beginning to take shape
- iii. Gym pits have been formed and gym floor is poured
- iv. Hopeful to form walls in February
- f. April 12, 2018 is the contractual date for construction completion
- g. Facility will open later than when construction is complete; much internal work to be done to set up staffing, computers, etc.
- h. On time and on budget for spring 2018 opening
- i. Current public opportunity through April to name the facility

6. Existing Recreation Center Update

- a. Agreed to facility assessment recommendations and facility phasing
- b. Reviewing proposals and interviewing firms Jan. 25th
- c. Design contract to council Feb. 6th
- d. Current public opportunity through April to name the facility

7. Executive Summary

- a. Fifty percent committed not including Pinkard contract
- b. Committee Question: If we have a giant chunk of money left, what will we do?
 - i. Unforeseen costs still can occur; still need Package B for new rec center
- c. Committee Question: Is there anything else left for council approval?
 - i. Package B and existing rec center
- ii. Package B might not be able to be completed in the five-year time period
- d. Committee Question: Is the new rec center area 112th completion to Chambers part of the budget?
 - i. Not currently fully funded
- ii. Committee Input: Completion might slide past five years but taking budget from somewhere else wasn't approved in original voter plan
- e. Committee Question: Will there be signals and safety at Chambers?
- i. To cross on Chambers there will be push buttons and marked signs to help crossing; Putting a signal at Chambers and 112th is part of package B
