SECTION 1. SECTION 3. That the property described in Exhibit "A" attached hereto and made a part hereof, now zoned PUD be rezoned I-2 as defined in the Commerce City Land Development Code.

SECTION 4. That the zoning map of the City of Commerce City, Colorado be and is hereby amended to reflect the rezoning approved by this ordinance.
