#### **Derby District**

- Centrally located within the heart of Commerce City
- There are 130 individual properties
  - residential
  - commercial properties
  - parks
  - churches
- Most of the original buildings which remain in Derby were built between the 1940s and 1970s

#### **Derby Review Board**

The Derby Review Board is a city council appointed board who reviews development applications for the Derby redevelopment area based upon the standards in the Derby design guidelines. The DRB also reviews all commercial catalyst fund requests.

#### Derby Façade – Commercial Catalyst Program

- City incentive program to help improve façades in Derby
- DRB authorizes catalyst fund expenditures
- Exterior improvements including storefront, landscaping & signage
- Commercial properties in Derby are eligible up to \$25k matching/annual
- Over \$200,000 in matching catalyst funds granted to-date
- Receives \$83,000 in allocations from city budget each year

#### **Financial Structure**



- City collects sales tax increment & remits to URA
- Base is \$170,625
- URA owes increment to developer per agreement for reimbursement of their improvements.

#### **Financial Structure**



- City collects sales tax increment & remits to URA
- County collects property tax increment & remits to URA
- URA owes increment to Kroenke for \$101 million investment (stadium & infrastructure)
- Kroenke owes City for \$12 million of bonds issued for Quebec & 56<sup>th</sup> Ave. improvements
- Kroenke's payment to City exceeds total TIF
