## Background

- Victim Services IGA
- Began discussing in 2016
- Developed concept in November, 2016
- Applied for BJA SPI Grant in January, 2017
  - Letter of support from both Chiefs
  - Letter of support from YHOP
  - Letter of support and commitment of resources from 17<sup>th</sup> Judicial District Attorney Dave Young
- Both Agencies approved 2018 Budget
- Awarded Grant on October 2, 2017
  - \$700,000
  - 20% (\$140,000) must be dedicated to research



## **SATF** Justification

- Need for improved and consistent sexual assault investigations in both Brighton and Commerce City
- The current case load of sexual assaults are overwhelming the current resources
- We currently have a combined Victim Services and both agencies have implemented "You Have Options Program"
- Goal was to increase capacity to investigate all crimes and develop a specialized group to investigate sexual assaults and manage sex offenders.



## **Grant Proposal**

- Create a combined task force that will investigate ALL sexual assaults and manage sex offender registry
- Have specially trained and focused investigators
- Commerce City Police Department will be the host agency for the task force
  - 1 Commander giving 20% of their time to overseeing the task force
    - 1 Brighton Police Department Sergeant
    - 2 Commerce City Detectives Currently Staffed
    - 1 Commerce City Detective new position partially grant funded
    - 1 Brighton Detective Currently Staffed
    - 1 Brighton Detective New position partially grant funded
    - 1 Brighton/Commerce City SA Victim Advocate (fully grant funded- VAWA)
    - Assigned District Attorney
    - (grant is for \$ 700,000.00 (partially fund positions over 3 years)





#### **Grant Proposal**

- Improved investigation of sexual assaults through best practices
- Ensure trained investigators are immediately assigned to all sexual assault investigations
- Improved service to victims of sexual assault
- Ability to handle the increase in reported sexual assault as a result of implementing "You Have Options Program"
- Increase the capacity overall in the investigations units
- Develop and implement best practices in the commerce of the comme

- Neither agency have sufficient space to house this task force
- Currently negotiating with Adams County Government
- 124<sup>th</sup> and Sable
- Providing all furniture
- Victim interview room
- IT Infrastructure
- Full use of conference center §
