Mayor Ford opened the public hearing.

Planner Kerns presented the case. This district represents Buffalo Run East and West and is seeking an amendment to the service plan to increase the authorized amount of debt from \$25 million to \$43 million in order to complete public improvements along the south side of East 120th Avenue.

Mark Bush appeared on behalf of the applicant. He stated the district anticipates increasing mill levy from 42.5 to 49.

No one came forward to speak on the matter and the public hearing was closed.

A motion was made by Council Member Teter, seconded by Council Member Diaz, that this resolution be adopted. VOICE VOTE: Unanimous, all present affirmed.

RESOLUTION APPROVING ECONOMIC DEVELOPMENT BUSINESS INCENTIVES FOR ARRIVO

Economic Development Director Claymore reviewed the history and purpose of the city's incentive program. The applicant, Arrivo, could bring \$10 million in capital investment, 75 jobs and estimated tax and fee revenue of \$390,000. Proposed incentives total \$182,500, or 2 1/2 % of the overall capital investment by the applicant.

Arrivo's Project Manager was available to answer council questions.

A motion was made by Council Member Teter, seconded by Council Member Douglas, that this resolution be adopted. VOICE VOTE: Unanimous, all present affirmed.

11. Ordinances on 1st Reading

Ord 2150

AN ORDINANCE AMENDING SECTION 5-4500 OF THE COMMERCE CITY REVISED MUNICIPAL CODE TO ADOPT THE 2017 NATIONAL ELECTRICAL CODE AND REPEALING AND REENACTING SECTIONS OF THE 2006 INTERNATIONAL CODE COUNCIL ELECTRICAL ADMINISTRATIVE PROVISIONS.

Building Official Patrick Buckley presented the ordinance. The state electrical board adopted the 2017 National Electric Code at their January 2017, meeting and it went into effect at the state level on July 1, 2017. Mr. Buckley reviewed key changes from the 2014 edition.

In response to council questions, two electrical inspectors have been educating themselves on the new code.

A motion was made by Council Member Douglas, seconded by Council Member Diaz, that this ordinance be introduced by council as seated and approved on first reading. VOTE:

A motion was made by Mayor Pro Tem Teter, seconded by Council Member Huseman to change the study session on January 22, 2018, to a special meeting for the purpose of conducting city manager and city attorney evaluations and any other city business.

Mayor Ford asked for council support in directing staff to make repairs to Brighton Road between 104th and 120th and hold a study session regarding whether or not to deannex the road.

A motion was made by Mayor Pro Tem Teter, seconded by Council Member Douglas, to direct staff to maintain Brighton Road between 104th and 120th and present pros and cons for de-annexing the road.
