Core City & MHGP

- Will you want more projects funded in the core city (more than the \$6 million now funded)?
 - Need to build \$2,000,000 regional drainage pond on MHGP, to be funded from land sale proceeds
 - May need to finance \$11,000,000 of horizontal infrastructure (drainage, sewer, streets, & water mains) on MHGP
- MHGP: Treat infrastructure as next 2-K project or fund it with loan from fund balance?

Derby Area Projects

Will you want more projects funded in Derby (more than the \$752,000 now funded)?

 Could fund entrance sign now using 2018 left-over catalyst funds



Irondale & Area Projects

Will you want more projects funded in the Irondale area (more than the \$7.8 million now funded – not including 88th Ave.)?

- Need to obtain more funding for 88th Avenue
- Could start purchasing land for regional drainage



East-West Corridor Improvements

- 120th Avenue Widening:
 - Mark Bush is building south 3 lanes, Chambers to Buckley/High Plains Parkway (City share: \$1MM)
- 112th Avenue Widening:
 - Oakwood Homes wants to widen from Chambers to Parkside Drive (total: \$10MM; City share: \$4.5MM)
 - Blackhawk to Chambers (regional drainage pond,
 Second Creek outfall thru park, structure under
 O'Brian, & road improvements = Total: \$20.5MM;
 City share: \$10MM)
 - Parkside Drive to Tower (total: \$11.5MM; City share: \$5.7MM)

East-West Corridor Improvements

- 96th Avenue Widening:
 - Budgeted \$1.2MM to start some design work
 - 2018 PW requested:
 - \$7,550,000 for I-76 to Hwy 2
 - \$20,500,000 east of Hwy 2
 - We have not received pressure regarding 96th
- 56th Avenue Improvements:
 - 2018 request for \$6,830,000 for Brighton to US85

Commerce

E470 Corridor Improvements

- Streets:
 - No cost estimates
- Water Mains:
 - \$15.9MM to build system at once (2015 estimate)
 - \$90.1MM to build individually
 - \$29.1MM for pressure zone
- Sewer Mains:
 - \$23.2MM to build system at once (2015 estimate)

Commerce

- \$41.6MM to build individually

E470 Corridor Improvements

Dedicated Funding Sources:

- E-470 Commercial Area GID
- E-470 Residential Area GID
- One or more Metro Districts
- SACWSD?



Project Funding Concepts

Options:

- Continue with projects as funded
- Change funding by area based on new priority
- Supplement funding for certain area(s) using 2-K
- Explore alternate funding mechanisms:
 - Developer/metro district reimbursement agreements
 - Raise impact fees to fund actual cost
 - Other?

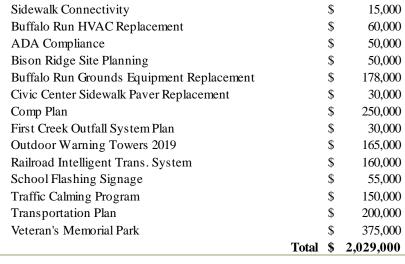
