

7/1/2018 - The scheduled attorney meets with the prosecutor and all defendants that are in custody. If the hearing is on video, the attorney meets with the prosecutor at city hall before going to the jail and meeting with the defendants. The attorney then appears before the judge with the defendant and each case is handled. Since there are multiple defendants and some defendants have multiple cases, it is not practical to require the attorney to track the amount of time they spend with each defendant
