## COLORADO MUNICIPALITIES WITH VOTER-APPROVED MARIJUANA EXCISE TAXES (THROUGH FALL 2018)<sup>1</sup>

The following Colorado municipalities have approved excises taxes that appear to authorize a tax on the wholesale transfer of marijuana and/or marijuana products. "Unpr. RMJ" means transfers (and sometimes "first transfers") of unprocessed retail marijuana from cultivation facilities. Sales refers to wholesale transfers. Some taxes apply only to transfers originating in the city. This list does not reflect municipalities that have actually imposed the tax or approved ballot issues for municipalities that have not authorized marijuana.
