

### **General Updates**

- Continued to meet with Extraction Oil & Gas regarding Regional Operator Agreement and Best Management Practices (BMP's).
- Staff continuing to monitor SB-181 and oil & gas legislation at the state level & it's potential impacts on Oil & Gas development in Commerce City.
- Held additional meeting regarding emergency response and coordination with South Adams County Fire District & Brighton Fire District, and potential items that could be incorporated into BMP Document
  - Randall Weigum (SACFPD) will speak generally on this process at our April 1st Oil & Gas speaker series.
- FHU continuing to develop Oil & Gas impact fee
