## Mile High Greyhound Park Status Update

#### August 19, 2019



#### Purpose



- Provide update on status of MHGP preparatory work
- Obtain CCURA Board's direction on how to handle Delwest's Design Guidelines deadline:
  - Amend the Purchase and Sale Agreement to extend the deadline for approval past Due Diligence date

OR

- Terminate the agreement
- Staff anticipates anticipate Delwest will waive Due Diligence on 8/21 per the PSA except for survey.
  - This would make Delwest committed to close on the project and would be responsible for the preliminary engineering costs they have put in to date

## **Actions Since Last Update**



- Purchase and Sale Agreement, Owner's Representative Agreement, and the Modified Master Developer Agreement have all been executed
- Delwest has ordered and received title commitment from Land Title
- Delwest has submitted draft design guidelines
- Staff is working with County to secure funds for LIHTC
- Delwest is proceeding on schedule with infrastructure engineering and plat
- City appropriation of \$2.5M for detention pond escrow is going to second reading on Sept. 16
- Delwest is in progress on their soils testing
- Delwest has ordered the survey

#### **Recap of Agreements**



- Purchase and Sale Agreement locks in Delwest's commitment to purchase residential land and take over as master developer
- Owner's Representative Agreement with REGen gives master developer rights to Delwest and secures services as owner's representative
- Modified Master Developer Agreement (MDA) locks in Delwest's responsibilities as master developer

### **Design Guidelines**



- Per the PSA, Delwest must receive final approval on their Design Guidelines by Wednesday, August 21
- Delwest submitted a draft with exhibits on August 12
  - The first draft did not include exhibits and was not up to City standards for acceptance
  - Staff provided comments and Delwest submitted exhibits but has not responded to the comments
  - Design Guidelines still need one or two more iterations
  - Staff cannot recommend final approval at this time

#### **Delwest Accountability**



- Under the PSA, Delwest must receive CCURA approval on their design guidelines by the end of the Due Diligence Period, which ends at 5:00 PM on August 21
  - Default entitles CCURA/City to terminate PSA after 10 day notice and cure
- Under the MDA, Delwest has a November 11 deadline to finalize the design guidelines
- Staff recommends extending the PSA deadline to match MDA

- Delwest must submit the plat to City
- Delwest must submit PUD permit applications to City
- Delwest must obtain public improvement agreement
