
## Background

- Veterans Memorial Park is 4 acres of an 8.5 acre site that includes Eagle Pointe Recreation Center.
- The park opened in 1971, the recreation center opened in 1987, and Veterans Memorial was constructed in 1988 and renovated in 2010.
- Four residential lots along Forest Drive have been added to the park.
- In December 2018 information about the renovation was presented to City Council.
- City Council requested additional inclusive elements and a flush restroom.

# **Project Budget**

- The contract cost was higher than initial project estimates due to:
  - Site preparation and site work increases related to drainage (approximately \$130K)
  - Parking lot concrete and asphalt work related to accessibility (approximately \$50K)
  - Miscellaneous items throughout the project (approximately \$60K)

Project Budget (re-appropriation funding source)

• Department of Local Affairs (DOLA) is responsible for the administration of the Conservation Trust fund (CTF)

The Conservation Trust Fund receives 40 percent of Lottery proceeds. Local parks and recreation providers receive money from the Conservation Trust Fund in proportion to their population so that every town, city, county and special district in Colorado benefits. The Lottery funds open space and land acquisition, equipment purchases, facility development, park maintenance and renovation or restoration of local facilities.



### **Proposed Schedule**

- Execution of contract in December 2019
- Notice to Proceed to contractor late December/early January
- 120 days to construct (plus any weather days)
- Construction significantly complete by late April/early May
- Punch list items completed by end of Q2 (June)



### Next Steps

- Obtain Council's authorization for construction contract December 16<sup>th</sup>.
- Obtain Council's authorization for re-appropriation ordinance December 16<sup>th</sup>.
- Route contract for signatures.
- Issue official notice to proceed to Designscapes Colorado.
- Open park Q2 2020.
