1. Why are you applying to be on the city council?

I moved to Commerce City when I was 8 years old. My formative years were spent here and have shaped who I am as a person. I remember where we came from, and I have seen so many positive changes. I also know that there is still work that needs to be accomplished. I work intimately with the community as a paramedic in Commerce City (on both the South and North sides) and I see on a consistent basis the needs of the residents. I would love to be a voice for them as someone who knows what they're going through, not just as someone who spends a few hours here and there just talking to them.

2. How is your experience and background relevant to being on the city council?

As a first responder working in the heart of the city, I have a unique perspective and can see firsthand into the lives and wellbeing of the citizens within our community. My skill set allows me to connect with people from all areas of Commerce City and all walks of life. From the brand-new homes and businesses in the North, to the basements that house entire families, to the homeless camps along Sand Creek. My level of care does not change no matter the cross streets I find myself at. I am also a United States Navy veteran. I spent 7 years as an Air Traffic Controller and work well as a member of a team. Completing objectives that push the group toward accomplishing the mission energizes me and knowing how it impacts my own community drives me to overcome obstacles.

- 3. What are your thoughts on the relationship between the historic city and the northern range?

 When the Northern range first came to be, there were some that wanted to change the name of Commerce City to something other than Commerce City. Obviously, that did not happen but it was a bit of a sore spot for some of the folks who have lived here for a long time. To those that remember the ordeal, they don't think about the North side, there is no relationship other than to recall the failed effort. Other people in the Southern part of the city feel like they have been forgotten about. With all of the new building going on they feel like improvement projects for the heart of the city are on hold and the resources are being taken by new development. As an example, the new Bison Ridge Recreation Center is beautiful, but a lot of the classes that were originally at Eagle Point were moved up north and there is some contention that opportunities were lost in the south in favor of giving them to the northern residents. Gentrification may not have been the intention, however the planning worked out that way. I personally believe that our two communities are our greatest asset, and we need to be able to grow for the future without forgetting about our history and where we came from. This is another reason why I am applying to be on the council.
- 4. What do you believe to be the three most pressing challenges or concerns in the Commerce City Community.

Ever Growing Homeless Population - With Denver going through and pushing the transient community out of Denver City limits, they have migrated to Commerce City. Figuring out a way to balance the public health and safety for the current residents and the transient population.

Lack of retail or dining options - There has been tremendous growth in the dining facilities up North, but down south there has not been much in the way of new dining options. I think a survey of available space for dining and retail options needs to be done so we are able to see what we are working with and where we can add.

Current City Employees and the Status Quo - I was speaking with a gentleman who had a great vision to open a small coffee shop on Parkway Dr, but got extremely discouraged when going to file paperwork and get the business running. He talked about how the people in the offices were so used to small town life, that when more, or larger, projects came in they were overwhelmed and didn't know how to handle the influx of work. He has since put the coffee shop on hold, but hopes to someday have a coffee shop here in the city.

5. What do you see at the three biggest opportunities for Commerce City Right now?

Land use and Development - We have a unique opportunity in Commerce City. We are able to build new homes and business up North, but we also have the opportunity to revitalize South Commerce City. The Stapleton area is a great example of how to revitalize, while staying true to the heart of our history.

Location - We are in a great spot as far as highway usage, 270 runs right through the heart of the city and 76 gives access to 470 both of which are great options to get to the airport. We need to capitalize on that location and add places for people to stop and grab a bite to eat on their way out to the airport.

Industry; Pride in our History - We come from a long line of hard workers. Commerce City has some great industries within its boundaries. Our residents are able to find work close by their homes and are able to provide for their families. As Commerce City expands, there are more opportunities for companies to move in and make this their home. It is not uncommon for our neighbors to be up at the crack of dawn and home when the sun goes down. There are dedicated employees down every street. Our resiliency is what has kept Commerce City thriving for as long as it has.

6. What concerns, if any, do you have about serving on the City Council?

The only concern that comes to mind is that I have not served on City Council before. There is a time and place to start, and for me this is it. I am committed to putting in extra effort to get up to speed as quickly as possible.

7. What does "Quality Community for a Lifetime" mean to you?

Quality Community for a lifetime means that we are planning and growing a city for people to settle into, to plant roots in and have generations of their family living here. A community where we are able to work and raise a family without concerns for safety or lack of working options.

- 8. What local government or non-profit boards or commissions have you served on? While I have never served on a board, I have been a volunteer with multiple organizations. I have been the Paramedic on call for multiple 9News Health fairs, volunteered with the USO, been involved with several veteran run programs to assist with other veterans or active duty service members.
- 9. Have you participated in the Commerce City Civics Academy?

 I have not, but I would welcome the opportunity to do so.
- 10. How long have you resided in Commerce City?

My family moved to Commerce City in 1992, I moved away in 2005 to serve my country in the United States Navy, and returned in 2012.

11. What is your favorite place in Commerce City?

Growing up here, there are a lot of places I reminisce about, like behind Fire Station 1 where my best friend and I smoked our first stolen cigarette. I would say my favorite memories are from Fairfax park where they used to hold the fireworks display on the Fourth of July. The whole community would come out for the event. I remember vividly community camaraderie as we all ate ice cream and popcorn on blankets under the fireworks. As an adult, my favorite place is the dog park at 102nd and Havana. My job comes with a lot of stressors, so being able to go outside and take my dogs to run around, off leash, is important for my mental health and for my dogs to get their exercise. I also enjoy the restaurants that do call Commerce City home. Most Saturday mornings you can find me and my family (sometimes my crew) at Stephanie's Coffee Shop right next to Best Yet Flowers.
