#### CURRENT CONCERNS AND TRENDS

- March 7, 2021, 600-800 Street Racers shut down I-225 in Aurora causing major traffic delays and community frustration. Aurora Police Department had considerable difficulty addressing the situation.
- ► April 3, 2021Speed Racing event in downtown Denver cited as the cause of a traffic fatality.
- ► FOX31/Denver PD reported that Street Racing has tripled since the beginning of the pandemic.

# COMMERCE CITY QUALITY OF LIFE ISSUES RELATED TO STREET RACING

- ► Commerce City is typically not a location where street racers hold races.
- ► Commerce City has been a hub for racers and car clubs to gather prior to or after their pre-planned events.
  - ▶ Pioneer Park (Summer of 2020)
  - ► Monaco Park
  - ▶8100 & 8300 block of Tower Road

### CFS SUMMARY

- Over a 3 year period, Commerce City Police has received <u>124</u> calls for service related to street racing. These CFS include:
  - ▶ Racing
  - Cars gathering before, during or after racing
  - Noise complaints as a result of racing and/or gathering (music, revving of engines, squealing tires, etc.)

### CHALLENGES

- ▶ Resources to deal with large street racing groups gathering in locations around the city.
- ► When officers conduct enforcement on violators, drivers simply do not stop and their actions do not warrant a high speed pursuit. Therefore identification and accountability is difficult.
- Street Racing groups are mobile and have creative ways to communicate with members making it difficult to be proactive.

- ► Active involvement with the Regional Street Racing Work Group. \*\* Fusion Center Intel communication is key with this work group.
- Mutual Aid Agreement with Adams County L.E. partners
- Enforcement where possible
- Ongoing development of operational plans to address the constant changes in street racing and car club trends.

# COMMERCE CITY MUNICIPAL ORDINANCES

#### ▶11-2105 Street racing and exhibition of speed- Prohibited

- ▶Increase fine schedule to maximum amount.
- ▶ Require 30-day jail sentence for second conviction.
- ▶12-3000.5 Trespassing for the purpose of furtherance of street racing exhibition of speed
- ▶3-2304 Penalties
  - ▶Add subsection to increase the minimum penalty for violations of 11-2105 to maximum allowed for a municipality.

# RECOMMENDATIONS FOR ADDITIONAL MUNICIPAL ORDINANCES

Ongoing mutual aid operations.

Formalize investigatory process and partner with local agencies to potentially charge at a higher level.

Educate the street racing community.

Utilize technology to identify participants and proactively communicate the consequences if involved in street racing (ALPR).

Enlist community support for reporting and deterrence.

Utilize undercover investigators to help identify and build criminal and civil cases.

#### FUTURE EFFORTS

## ADDITIONAL ACTIONS

- Physically close Pioneer Park after hours.
- Signage to close roadway during peak hours- Enables additional enforcement tool.
- ► Signage to enhance PD ability to charge violators- Trespassing signs that spells out the prohibition of exhibition of speed (squealing tires, revving engines) on private property. Work with businesses for posting.

# RECOMMENDATIONS WITH BUDGET CONSIDERATIONS

- ► Covert mobile ALPR unit- Approximately \$24K per unit.
- ►LiveView mobile trailer surveillance system
- ► Close Pioneer Park after hours w/ solar powered gates
