Planner Jared Draper presented the case on behalf of the applicant. The applicant, Fiore & Sons, is seeking to rezone their property from AG to I-2. A development plan is under review at this time; however, the applicant is proposing to use the site for storage.

Tony Fiore, appeared on behalf of the applicant. Mr. Fiore stated that his family acquired the property after it had been used as a gravel pit. In response to council questions, he stated that truck traffic would not be greater than what it has been in the past and there would be no more than three tenants.
