Chairman Ford opened the public hearing.

Finance Director Sheryl Carstens presented the budget. Ms. Carstens stated that revenues are estimated primarily from property tax at \$5.8 million and miscellaneous

revenue of \$655,000 from water capacity fees, joinder fees and investment earnings. Expenditures for the Series 2002 Debt Service Payment is \$745,000, and the 2013 Debt Service Payment is \$4.5 million. There are administrative expenditures associated with the two debt series and after paying expenditures, \$1.1 million will be added to the fund balance. The mill levy is certified at 1.7 mills.

No one appeared to address the board in favor of, or opposition to, the budget.

A motion was made by Vice Chair Bullock, seconded by Board Member McEldowney, that this resolution be continued to November 7, 2016. VOICE VOTE: Unanimous, all present affirmed.
