1. Call to Order/Roll Call

A regular meeting of the City Council of the City of Commerce City was called to order by Mayor Ford on August 6, 2018, at 6:02 PM.

6. Citizen Communication

Kevin Mallory, 10051 Joplin Street, came before the Council to ask for the installation of speed bumps on Joplin Street to deter drivers who speed on the street. Mayor Ford explained the process for applying for the installation of speed bumps on Commerce City streets.

Travis Gilcrest, no address given, also came before the Council to ask for the installation of speed bumps on Joplin Street to deter drivers who speed on the street.

Bruce Emery, 10071 Joplin Street, also came before the Council to ask for the installation of speed bumps on Joplin Street to deter drivers who speed on the street.

Mayor Ford asked staff to look into the speeding issue and to provide an update to Council and the residents on what is found.
