*Attorney Allen explained that a stipulated agreement has been reached with the licensee through their attorney. The licensee has terminated the bar tender responsible for the violation. The city is offering a penalty of a seven-day suspension, holding five days in abeyance for one year, and agreeing to a two-day fine in lieu of suspension.*

*Attorney Carr agreed with Attorney Allen.*

*After questioning the licensee regarding the violation and stipulated agreement, Hearing Officer Ablao approved stipulated agreement and advised the licensee that their fine would need to be submitted by Oct 1, 2018.*

*Hearing Officer Ablao approved the terms of the agreement conditioned upon no violations to the liquor code, rules, regulations and any local ordinances. Additionally, all employees who serve liquor are to be TIPS certified. The fine is to be submitted by October 1, 2018.*
