Carolyn Keith, Director of Parks, Recreation and Golf and Traci Ferguson, Parks Planner III, reviewed the GRASP CIPP Presentation and discussed the Geo-Referenced Amenities Standards Program that is used to measure service provided by parks and recreation systems. completed in 2007 and updated in 2016. Many of the strategic plan recommendations have been applied to the CIPP for implementation in addition to the scheduled maintenance and replacement schedule that the CIPP outlines. This utilizes a mix of funding sources including lottery, Adams County Open Space, park impact fees, the general fund, 2K, and grant monies. The five-year list of projects is growing and ever-changing based on a cycle to repair/maintain as well as requests that are initiated, damage that arises and necessary operating adjustments. Co-Chair Maillet shared a potential safety concern with slick concrete in the basketball court at Villages East and requested this to be followed up on.
