AN ORDINANCE AMENDING THE 2024 BUDGET OF THE CITY OF COMMERCE CITY, COLORADO, BY RE-APPROPRIATING REMAINING DONATIONS AND GRANTS BALANCES IN THE GENERAL FUND, POLICE DONATIONS FUND, AND GRANTS FUND, TOTALING \$202,154.60 AND AUTHORIZING THE EXPENDITURE THEREOF.

**Summary and Background Information:**

At the end of 2023, the City had various donations and grants funds with remaining balances at the end of the fiscal year. This "Carryover Ordinance" is being brought forward to carryover remaining balances of donations and grants from 2023 to 2024 for continued expenditures on programs related to those donations and grants.

The City does not budget for donations and grants as part of the originally adopted annual budget. Donations and grants are appropriated as part of a "Carryover Ordinance" or as part of additional stand-alone ordinances when grant awards are received throughout the year. Staff requests the remaining balances of these donations and grants be re-appropriated in the applicable funds for their intended programmatic purposes. These are remaining unspent balances from the end of 2023 and are not new money.
