A RESOLUTION AUTHORIZING AWARD OF CONTRACT FOR AV UPGRADES AT BISON RIDGE RECREATION CENTER TO BEACON COMMUNICATIONS LLC

**Summary and Background Information:**

The current A/V equipment at Bison Ridge Recreation Center is at the end of life meaning a hardware failure is likely and the manufacturer does not provide any warranty on the hardware. In order to keep the A/V running it is imperative to upgrade the end of life equipment. The new upgraded hardware would have an expected life of 5-6 years. The upgraded hardware will help to ensure the technology is reliable for City staff and public use at Bison Ridge Recreation Center. In addition, the technology has evolved over the last 5 years and will incorporate new technological advances in audio visual equipment including video conferencing capabilities in select rooms.

The costs for this project are included in the current IT budget.

The current tentative schedule is to kick-off the project the week of April 1<sup>st</sup>, 2024 and have the new system in place by December 31<sup>st</sup>, 2024. The City has conducted an RFP process in accordance with the City’s procurement policy.
