### **Summary and Background Information:**

### **Property Information**

- The property was annexed into Commerce City in 1989 and zoned AG. The property was rezoned in 2016 to be a part of the DIATC PUD. The name of the PUD is DIA Tech Center and it is proposed to have employment development north of E. 81<sup>st</sup> Avenue and west towards the Wildlife Refuge boundary and commercial development towards Tower Road.
- The applicant is currently in the process of platting this property for future employment uses although a specific user has not been identified.
- The applicant is proposing to include this newly rezoned portion of DIATC into the ECAGID, to be consistent with the remainder of the DIATC development Inclusion information
- The GID inclusion petition resulted from preparing this site for development and acquiring water resources from South Adams County Water and Sanitation District (SACWSD).
- The applicant has included into SACWSD.
