Purchase of Additional 4A Water

Summary and Background Information :

he City has the opportunity to purchase more 4A water from South Adams County Water and Sanitation District SACWSD). SACWSD is using funds from 4A water sales to raise more money for the purchase of augmentation water. ACWSD wants to buy augmentation water because it is necessary in order to have future 4A water available for use or the eventual build-out of the community. Without augmentation water, the 4A water cannot be made available on a ng term basis in the future. As stated before, the reason SACWSD wants to buy augmentation water now is that a rge block of water is available.

he City is in the process of purchasing additional 4A ERUs based on previous authorization from City Council and roposes to raise significant additional funds as discussed below. The specifics of the financial proposal will be the abject of an executive session because negotiations are still under way for the purchase of the water. The city will have urchased approximately 577 ERUs in 2016 & 2017 but will need another 1,723 ERUs in the future for additional cilities and parks. The city receives approximately \$500,000 in annual revenue in the Water Acquisition Fee Fund. It possible to use that to fund over \$6.5 million in a lease-purchase transaction. That would enable the purchase of a gnificant number of ERUs at the current discounted rate of \$6,850 per ERU (minus the connection fee). It is desirable purchase the ERUs without the connection fee since the price of water rights is escalating faster than the connection see charged by SACWSD.

he other option would be to use COPs to secure the funding for such a large water purchase, still using the revenue in a Water Acquisition Fee Fund to repay the COPs. However, that ties up the equity in a city facility resulting in the oportunity cost of not being able to use that equity to secure COPs for some other project. The other advantage of a ase-purchase deal is that the interest rate is estimated to be approximately 2.5-2.75% for the first 10 years. If city buncil decides to proceed in this manner, staff will solicit formal proposals for lease-purchase financing. That will lock the interest rate and determine the term of the lease-purchase structure.

he policy question for city council is, do you want to purchase more 4A water using a funding mechanism such as a ase-purchase arrangement in order to acquire additional water for future city use and achieve long-term security for e 4A ERUs?
