## AN ORDINANCE INCLUDING CERTAIN LANDS INTO THE COMMERCE CITY E-470 COMMERCIAL AREA GENERAL IMPROVEMENT DISTRICT

### Summary and Background Information:

#### Property Information

- The property was considered for annexation by City Council earlier in the evening on March 18<sup>th</sup> with a zoning of PUD. The name of the PUD is Nexus North at DIA and it is proposed to create an employment center.
- The applicant is planning to plat this property for future employment uses once the annexation is complete, although a specific user has not been identified.
- The applicant is proposing to include this property into the ECAGID.

#### Inclusion information

- The GID inclusion petition resulted from preparing this site for development and acquiring water resources from South Adams County Water and Sanitation District (SACWSD).
- The applicant is in the process of including the property into SACWSD.
