AN ORDINANCE INCLUDING CERTAIN LANDS INTO THE CITY OF COMMERCE CITY NORTHERN INFRASTRUCTURE GENERAL IMPROVEMENT DISTRICT

Summary and Background Information:

Property Information

- The property was annexed into Commerce City in 2008 as a part of the Northern Range Enclave Annexation and remained vacant for a number of years.
- The property consists of approximately 61 acres of land zoned industrial.
- This applicant is proposing to develop this site for 5 buildings, including office, flex, warehouse, and light industrial activities totaling approximately 953,000 square feet.

Inclusion information

- The GID inclusion petition resulted from annexing into Commerce City and acquiring sanitary sewer resources from South Adams County Water and Sanitation District (SACWSD).
- The applicant has included into SACWSD.
