REQUEST

Approve Johnny Barajas as an additional Relief Judge for Commerce City Municipal Court who may cover in the absence of the Presiding Judge.

BACKGROUND

The Commerce City Municipal Court would like to add an additional Relief Judge. City Council has the authority to appoint a Relief Judge through Resolution. A Relief Judge can perform the same duties as the Presiding Judge in the event the Presiding Judge is unavailable. The appointment of an additional Relief Judge will give the Municipal Court greater flexibility in operations. Without Relief Judges, the Municipal Court cannot function in the absence of the Presiding Judge.

This resolution authorizes the appointment of Johnny Barajas as a Relief Judge for Commerce City Municipal Court. The pay for a Relief Judge is set as \$100 per hour. The appointment will remain in effect until the Presiding Judge resigns, the appointed Relief Judge resigns, or the appointments are revoked by City Council.

Johnny Barajas has prior experience as a Judge in the region. He is currently the Brighton Municipal Court Presiding Judge, is a retired Denver County Court Judge, and a former Adams County Magistrate. He resides within Adams County.
