*Omar Yusuf, City Planner, presented the case to the Commission.*

*Commissioners asked why the case appears before the Planning Commission rather than the Zoning Board. Staff explained that all zoning map amendments require a Planning Commission recommendation before City Council hearings. Annexation itself is heard exclusively by City Council, not the Commission.*

*Annexation hearings at City Council are scheduled for:*

- *First reading: July 6*
- *Second reading: August 3*

*Commissioners sought clarification on the tower lease terms. Staff reported:*

- *Lease was originally initiated in 1999, with a revised lease dated 2008.*
- *The lease automatically renews for up to five terms, each lasting seven years.*
- *The lease does not have a definitive expiration date but continues under the auto renewal structure.*

A motion was made by Commissioner VanHeusen, seconded by Alternate Commissioner Nelson, that the Planning Commission enter a finding that the requested AG (Agricultural Zoning District) Zoning for the property located at Northwest corner of E. 88th Avenue & Tower Road contained in case ZON26-0003 meets the criteria of the Land Development Code and based upon such finding, recommend approval of the AG (Agricultural Zoning District) Zoning.
