CDBG History & Primary Objective

- Community Development Block Grant (CDBG) is authorized under Title I of the Housing and Community Development Act of 1974, as amended
- It is a formula grant, with a primary objective of the development of viable urban communities
- Viable communities are achieved by providing the following, principally for persons of low- and moderate-income (LMI):
 - o Decent housing
 - o Suitable living environment
 - Expanded economic opportunities



CDBG Eligible Uses

- Public Improvements (Streets, Sidewalks, Parks, Sewers, etc.)
- Public Facilities (Neighborhood centers, non-profit centers, homeless facilities)
- Housing Rehabilitation

Commerce

- Acquisition of land or real property to be used for eligible purposes
- Economic Development Activities
- Public Services Including: healthcare, homeless services, literacy, youth services, senior services
- Planning and Administration

All CDBG activities must target low- to moderate-income (LMI) individuals, households, and neighborhoods (80% Area Median Income and below).

What are the ConPlan and AAP?

- Consolidated Plan (ConPlan) covers program years 2025 2029
 - CDBG is administered through the ConPlan, which covers a five-year period
 - Helps grantees determine activities and organizations to fund during five-year period
 - Describes community needs, resources, priorities, and proposed activities to be undertaken
 - Commerce City will complete its next ConPlan in 2030
- Annual Action Plan (AAP) covers program year 2025
 - The AAP is submitted to HUD every year of the five-year ConPlan cycle. This is the first year of the current ConPlan cycle
 - Describes specific planned uses of CDBG funds for the coming year



How was the ConPlan Developed?

- Commerce City is a member of the Adams County HOME Consortium and therefore is only required to complete an abbreviated ConPlan. Adams County completes most of the data-heavy sections on behalf of the Consortium members.
- Needs Assessment & Market Analysis
 - Data Sources: 2019 2023 American Community Survey (census) data
 - Data analysis completed by Civitas
- Strategic Plan & Action Plan
 - Community input provided via community survey
 - Stakeholder input provided via stakeholder survey and stakeholder consultation sessions in coordination with Adams County, Westminster, and Thornton
 - Civitas and CDBG staff used data analysis and community/stakeholder feedback to develop priority needs and goals for five-year ConPlan period.
