## BACKGROUND/REQUEST

Notice of Council business to direct Council to support the memorial for Isabella Salas Morales. As you may recall, on October 7, 2024, Council directed staff to work with Isabella's family to plan a permanent memorial in her honor—a commitment that was made and one that has deeply resonated with the family and our community.

Since that time, staff has worked diligently to fulfill this promise. Public Works reached out to the family in October 2024, and after thoughtful conversations, they collectively agreed on a memorial bench. Staff have since collaborated with Isabella's church to select a meaningful location, and both Jeff Bowman and John Bourjaily have kept the family informed throughout the process.

### **Project Detail, breakdown of costs for the memorial bench:**

Bench - approximately \$1800

Pad - approximately \$2,600 (based on previous concrete work our contractor has performed)

We already have the bench type and details figured out; we just need to order it.

Lead time for it is about 6 weeks.

For the pad, we already have Orozco under contract. They have done the same type of job for us before.
