## REQUEST

Approve an ordinance to amend the 2025 Budget by recognition of the Colorado Department of Local Affairs ("DOLA") Law Enforcement Community Services Grant Program in the amount of \$10,025.

## BACKGROUND

This grant will create an amendment to the 2025 Budget of the City of Commerce City, Colorado for the recognition of grant funds from the Law Enforcement Community Services Grant Program in the amount of \$10,025. There is no match for this program.

The Law Enforcement Community Services Grant Program provides funding for law enforcement community service projects. CCPD's project will purchase and distribute, through the Crime Prevention Unit, steering wheel locks, gun locks and air tags. Secondly, this project will purchase and distribute, through the Co-Response Program, hygiene kits, socks, mittens and hats to vulnerable residents.
