REQUEST

Approve Resolution 2025-163 ratifying the award of a contract for emergency streetlight repairs and wire replacement on Highway 2 from 72nd Avenue to 112th Avenue to electrical vendor, Morton Electric, Inc.

BACKGROUND

All copper wiring in the City-owned and maintained streetlights along Highway 2 from 72nd Avenue to 112th Avenue wiring was stolen. This theft left the lights dark and inoperable until a master electrician could be hired to reinstall the wiring. Due to the risk that this dark corridor posed for public safety, emergency steps were taken to repair the streetlights as quickly as possible.

To comply with current procurement practices, Public Works solicited quotes from three different vendors to make the immediate and necessary repairs. Morton Electric, Inc. was identified as the best vendor to complete this work.

In addition to repairing the streetlights, Public Works also created a deterrent plan for any future copper wiring thefts in this area.
