

**A RESOLUTION APPOINTING MEMBERS TO THE ARTS & CULTURE
COMMISSION**

WHEREAS, pursuant to Commerce City Charter Sec. 11.1, the City Council has the power to create boards and commissions, and members of the boards and commissions shall be appointed by the City Council;

WHEREAS, City Council has created a new commission, the Arts & Culture Commission by the approval of Ordinance 2767;

WHEREAS, the City Council wishes to appoint the current members of the Cultural Council as the founding members of the Arts & Culture Commission;

WHEREAS, Council is desirous of appointing and reappointing board and commission members to a term expiring as stated below.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE CITY, COLORADO, AS FOLLOWS:

SECTION 1. Findings. The recitals to this resolution are incorporated as findings of the City Council. This resolution is found to be necessary for the preservation of the public health, safety, and welfare and in the public interest.

SECTION 2. Appointment. The City Council hereby appoints the following persons to the respective boards and commissions, commencing on **August 18, 2026**, and continuing until expiration of their terms of appointment, or until such time as the member's successor shall be seated, whichever date shall last occur.
