REQUEST

Approve a resolution approving an IGA with Colorado Legal Services for a landlord/tenant legal services program.

BACKGROUND

Colorado Legal Services is a non-profit organization that has helped low-income individuals including seniors in Colorado for over 90 years. CLS' mission is to provide meaningful access to high quality, civil legal services. Some of these services are provided through legal aid and pro bono attorneys, law students and others. CLS provides its services through 13 offices located throughout the State. The administrative office is located just outside of downtown Denver. Adams County residents are served by the Denver CLS office. CLS is primarily funded by grants (including the State of Colorado, Department of Health and Human Services, Legal Services Corporation, Colorado Health Foundation, and the Department of Justice) and contracts.

Colorado Legal Services approached the City in 2018 to support a two-year pilot program for support disadvantaged residents with legal services as it relates to landlord/tenant situations. The City renewed its support for this program in 2021, and is requesting support for a third two-year commitment.
