REQUEST

Per the City's Citizen Participation Plan, the following steps need to be taken:

1. Draft the 2024 CAPER
2. Publish the 2024 CAPER on the City's CDBG webpage and provide physical copies around the Core City for public review. Consider any comments submitted.
3. Publish in the newspaper, newsletter, website and others a notice to review and comment on the draft 2024 CAPER. This starts the required minimum 15-day public comment period which will end of December 1st, 2025 at 4pm.
4. Hold a Public hearing on the draft 2024 CAPER and consider any additional comments from the public.
5. Present the 2024 CAPER to the City Council for submittal to HUD – scheduled for December 1st, 2025.
6. Post the approved 2024 CAPER on the City's website.
7. Submit the 2024 CAPER to HUD in the IDIS software by December 27, 2025.

Staff will make a visual presentation at CC meeting. The purpose of the presentation is to:

1. Review the progress of all active CDBG projects described within the draft 2024 CAPER
2. Consider any public input on the 2024 CAPER
3. Answer any questions

BACKGROUND

In 2016, the City became an Entitlement Community and now directly receives funding from the Community Development Block Grant (CDBG) program. As required by HUD, the City must submit an annual CAPER to publicly account for how the CDBG funds were utilized in the prior Program Year.

Each year, the CAPER is due to HUD 90-days after the end of each CDBG Program Year. This equates to December 27, 2025.
