REQUEST

Approve a budget ordinance to amend the 2025 budget of the City of Commerce City ("City") to recognize the grant award from the Colorado Highway Safety Office in the amount of \$10,560 for Commerce City Police Department ("CCPD") during Click It or Ticket enforcement periods.

BACKGROUND

The City has been awarded grant funding for the 2025 Colorado Department of Transportation Click it or Ticket campaign. This grant funds overtime enforcement of Colorado's child passenger safety and adult occupant protection laws through speeding and other aggressive/hazardous driving contacts during authorized time periods. Funds will be used to strictly enforce all child, teen and adult driving violations.

This ordinance is submitted to amend the 2025 budget recognizing funds from the grant. Commerce City Police Department will follow all requirements of the grant and provide enforcement during the designated enforcement campaign calendar.
